Interpreting Services Information & Fee Schedule

Basic Instructions for Requesting an Interpreter:

- 1. For regular requests, please call the Interpreting Department at 614-841-1991 during regular business hours, 8 a.m. to 5 p.m.
 - a. Please do not leave interpreting requests or cancellations on any DSC voice mail.
- 2. The following information will be needed when giving the interpreter request:
 - a. Name of the deaf or hard-of-hearing consumer
 - b. Date and time of the assignment
 - c. Estimated length of the assignment
 - d. Address of the assignment (include ALL relevant information, such as suite number)
 - e. Contact name and number for the assignment
 - f. Your name and phone number
 - g. Billing address, phone number and authorizing person's name and phone number

Regular Assignment	\$52.00 / hour	Assignment begins during regular business hours – 8 a.m. to 5 p.m.
After-hours Assignment	\$62.00 / hour	Assignment begins after regular business hours – 8 a.m. to 5 p.m. This includes all weekend, evening and DSC holiday hours.
Legal Assignment	\$58.00 / hour	Assignments include but are not limited to mediation, lawyers' consultations, court appearances and hearings. DSC reserves the right to determine legal aspect of assignment
Last-Minute Assignment	\$62.00 / hour	Assignment is given to DSC with less than 48 business hours notice.

All rates are quoted as per hour per interpreter.

- Please note that any assignment that is two (2) hours or longer in duration may require two interpreters.
- For assignments lasting longer than one (1) hour, DSC will bill at thirty (30) minute increments.
- All assignments will be billed at 100% of the total requested time.

Cancellation Policy - To avoid a cancellation fee, 48 business hours notice is required for all assignments 2.0 or more hours in length. Assignments scheduled for less than 2.0 hours require 24 business hours notice. The cancellation fee for any assignment that is not properly cancelled is 100% of the total requested time.

Failure of the customer or the customer's client to show up for the scheduled appointment will be billed at the same rate as a cancellation.

Travel Policy – DSC is happy to serve the interpreting needs that are outside Franklin County; however, for all assignments that are outside the county line, driving time and round-trip mileage (50.5¢ per mile) will be added to the actual hours of interpreting. The driving time and mileage will be determined from 5830 N. High Street, Worthington to the address of the assignment. Additionally, all assignments requested through our on-call interpreter will be charged a one hour travel time fee for after hour assignments.
